


Quarterly Total Fund Relative Attribution - September 30, 2014

The following analysis approaches Total Fund Attribution from the perspective of relative return. Relative return attribution separates and quantifies the sources of total fund excess return relative to its target. This excess return is separated into two relative attribution effects: Asset Allocation Effect and Manager Selection Effect. The Asset Allocation Effect represents the excess return due to the actual total fund asset allocation differing from the target asset allocation. Manager Selection Effect represents the total fund impact of the individual managers excess returns relative to their benchmarks.


Asset Class Under or Overweighting




Cumulative Total Fund Relative Attribution - September 30, 2014






Quarterly Summary and Highlights

- School Fund's portfolio posted a (0.25)% return for the quarter placing it in the 10 percentile of the Public Fund - Large (>1B) group for the quarter and in the 3 percentile for the last year.
- School Fund's portfolio outperformed the Policy Index by 0.53% for the quarter and outperformed the Policy Index for the year by 1.42%.


